

The GBI CxS Competency Course is a 3-day training course that covers all aspects of commissioning related to green buildings and industrial processes.

The course is open to all. Those wanting to become Competent GBI Commissioning Specialists must complete the 3-day course and pass the GBI CxS Examination, and must have passed the GBI Facilitator Examination

Pre-requisites

For participants who intend to become Competent GBI Commissioning Specialists, there are a number of pre-requisites. You must:

1. Attend at least 75% of the GBI CxS Competency course, **AND**
2. Pass the Competent GBI CxS Examination, **AND**
3. Have already passed the GBI Facilitator Examination.

You must also possess one of the following qualifications:

1. A technical personnel with at least 10 years relevant experience in design office and field commissioning works, and has obtained certification from other GBIAP recognised training programmes such as TABB Certified Supervisor, ASHRAE, NEBB, ACG, BCxA and CSA; **OR**
2. A professional engineer registered with BEM or a registered architect with LAM, with more than 5 years of testing and commissioning experience in building services; **OR**
3. A competent electrical engineer or supervising engineer registered with Suruhanjaya Tenaga.

Examination

The examination comprises a 2-hour multiple choice question paper as well as an individual project assignment and presentation.

Only participants who intend to become Competent GBI Commissioning Specialists are required to sit for the examination.

Upon passing the examination, you may then apply to be registered as a Competent GBI Commissioning Specialist. (Existing registered GBI Commissioning Specialists are required to pass the GBI CxS **AND** GBI Facilitator Examinations in order to renew their annual registration in 2017.)

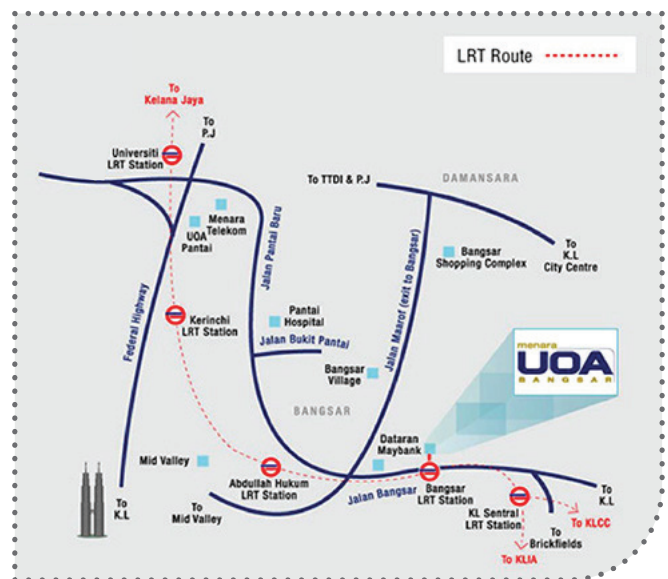
